

 <p><b>Trauma Research Translation</b></p>	<ul style="list-style-type: none"> <li>• Supported development of policies and procedures to standardize clinical trauma care</li> <li>• Developed infrastructure for dissemination and implementation of clinical practice guidelines (CPGs) to include Damage Control Resuscitation and COVID-19 in Austere Environments</li> </ul>
 <p><b>Direct Access to Physical Therapy (DAPT)</b></p>	<ul style="list-style-type: none"> <li>• Established a sustainable plan to spread and scale Direct Access to PT across the MHS</li> <li>• Standardized a booking protocol that directs appropriate patients to PT</li> </ul>
 <p><b>Colorectal Cancer Screening</b></p>	<ul style="list-style-type: none"> <li>• Developed a targeted public health communications campaign to educate patients and providers about colorectal cancer screening</li> <li>• Promoted the fecal immunochemical test (FIT) as an alternative to colonoscopy</li> </ul>

 <p><b>HIV Pre-Exposure Prophylaxis (PrEP)</b></p>	<ul style="list-style-type: none"> <li>• Developing project plans to increase HIV PrEP prescriptions to active-duty service members at increased risk for HIV infection</li> </ul>
 <p><b>Walk-In Contraceptive Service</b></p>	<ul style="list-style-type: none"> <li>• Establishing an enterprise-wide infrastructure to stand up walk in contraceptive services at 130 sites</li> </ul>
 <p><b>Opioid Overdose Education and Naloxone Distribution (OEND) Program</b></p>	<ul style="list-style-type: none"> <li>• Supported implementation of DHA's policy to increase naloxone co-prescriptions for patients at an elevated risk for opioid overdose.</li> <li>• Piloted implementation of a comprehensive OEND program at one MTF which was subsequently expanded to an enterprise-wide train-the-trainer program.</li> <li>• The proportion of individuals prescribed naloxone at the pilot site was 32.8% higher following implementation support compared to the MHS, on average</li> </ul>
